From the President's Podium

Bring a friend to our April lunch meeting! That is our special focus in April. If you know someone who is eligible to be a GBRTA member but who has not joined, invite him or her to join you on April 6. A guest's meal price will be reduced by 50%. Probate Judge T. R. Rowe is our featured speaker. In addition, Board members will report pertinent information about their committees.

Our profession continues to be at the forefront of the news both nationally and locally. The greatest emphasis of that news, unfortunately, has to do much more with funding than with education. Of immediate concern to us as retired teachers are our pension and health-related benefits. After several years of lobbying, retired teachers obtained Connecticut income tax relief, and for 2016 we are "only" being taxed on 75% of our income. For 2017 that is supposed to be reduced further to 50%. The fly in the ointment, however, is the financial quagmire that Connecticut is in, with a large projected deficit and every possible source of income under scrutiny. I urge all of you to set aside March 29 to attend "Lobby Day" in Hartford to meet with your local legislators. A poor turn out sends the message that we don't care, and consideration might then be given to losing the 50% reduction or even returning to full taxation! Don't want to drive? No problem. We will have a bus available. See details in the Lobby Day article on page 2.

In the Governor's budget proposal to the Legislature, teacher pension funding is again a topic. He has proposed that the cities and towns pick up one-third of the cost of the annual payments into the fund. This lessens the state taxation obligation but increases the local taxes. No changes to the benefits are being proposed —simply how to fulfill the funding requirements. Taxpayers are likely to see this news as another burden caused by the teachers' "sweetheart" deals. No mention will be made of the fact that there might not be such a problem if the State had contributed the required payments all along!

Talk to Your Legislators on Lobby Day

This year retired teachers will be able to exclude 25% of their Connecticut pension from 2016 state income taxes (versus 10% last year). That benefit was fought for and won by years of lobbying by the Association of Retired Teachers of CT (ARTC), of which GBRTA is an affiliate. The bill that provided that benefit also calls for a 50% reduction in the 2017 tax year, but, as Bob Pitzschler noted in his president's letter, with the State's budget deficit, that could be in jeopardy.

So speak up for yourself on Lobby Day, scheduled for March 29 at the legislative offices in Hartford. On Lobby Day, co-sponsored this year by ARTC, CEA-R, and UFT, retired teachers meet with their own state senators and representatives to explain the issues that are important to them and their colleagues—not only taxes but their pension and health insurance as well. Don't know what to say? On the morning of Lobby Day, the ARTC lobbyist and legislative committee will meet with retirees and provide fact sheets to facilitate their meetings with the legislators. Legislators and attendees are invited to continue their conversations over a light lunch.

The GBRTA, in conjunction with ARTC, will sponsor a Lobby Day bus to Hartford—with a \$5 charge for GBRTA members and a \$10 charge for non-members. It will pick up at the usual GBRTA stops in Fairfield (Villa Avenue Stop and Shop) at 8:00 AM and Trumbull (Penny Avenue commuter lot) at 8:15 AM. To reserve your place on the bus, send a check for \$5, made out to GBRTA, to Bob Pitzschler at 4 Laurel Ridge, Chatfield Farms, Beacon Falls, CT 06403. The check, with your phone number noted on it, should reach Bob by March 15.

ARTC Needs You

Would you spend \$50 a year to support an organization that from its founding in 1954 has:

- worked to maintain your pension and COLA;
- spent a decade lobbying for the exemption of your pension from the CT Income Tax;
- educated legislators about the differences between the funding of pensions of retired teachers and those of other State employees;
- protested the underfunding of your Health Insurance Premium Account;
- pressed for the repeal of the Federal Government Pension Offset and Windfall Elimination Provision (GPO/WEP)?

The Association of Retired Teachers of Connecticut (ARTC) has done all that and more. With its 8,000 members and 14 Affiliate Chapters, ARTC sponsors a *Meet and Greet Day* to inform newly elected legislators about the issues that concern retired teachers. To reach all State legislators, ARTC initiated *Lobby Day*, providing retired teachers with the opportunity to learn about the issues and then to meet and talk with legislators about their concerns.

As one of ARTC's 14 affiliates, GBRTA has a seat on ARTC's Board of Directors and its membership, legislative and insurance committees. In addition, GBRTA collaborated in the decade-long struggle to gain legislative approval for the exclusion of portions of retired teachers' pensions from the State income tax. Retired teachers with an average pension of \$50,000 saw their State Income Tax reduced by approximately \$400 on their 2015 tax return. The 2016 return should see a savings of approximately \$1,000, with a projected saving of \$2,000 for 2017 and future years —if the current legislation is maintained.
